BACKGROUND

The Illinois Judges Foundation awards the Harold Sullivan Scholarship to two or more eligible students attending an Illinois law school. The scholarship award is at least \$2,500.00, and up to \$5,000.00. The scholarship monies are paid by the IJF to the winning students' law school(s) to cover future tuition and related costs. Some law schools may award matching funds, thus increasing the value of a scholarship award. Please check with your law school to determine the amount of matching funds, if any, it will provide.

ELIGIBILITY

To be eligible, the applicant must meet the following criteria:

- Does not have a close relative who is a judge;
- Currently enrolled in an Illinois law school, with at least one academic year of law school left to complete (incoming 1Ls not eligible);
- Has community service or *pro bono* experience;
- Has financial need.

Applications, including essays, for the Harold Sullivan Scholarship must be received by 3:00 p.m. Central Time on July 1, 2022. All materials must be sent by e-mail to scholarship.ijf@gmail.com.

Letters of recommendation are not accepted, nor are personal or professional references.

Plaintiff Penny Pursuer has filed a personal injury action against Defendant Bill Meenot, arising out of an automobile accident that occurred in January 2021.

Plaintiff Penny claims she is permanently disabled and can no longer work as a waiter or participate in her pre-accident leisure activities, including yoga and rock climbing.

At trial, Defendant Bill seeks to introduce a video that he will testify he discovered on You Tube. The video was posted by "Pete the Pursuer" in July, 2021. Penny's husband is named Peter Pursuer. Peter has not been identified as a trial witness by either side.

In the video, Penny is seen exiting from the back door of her home. She sprints up a ladder to a diving board, and executes a triple somersault before plunging into the swimming pool. When she emerges from the water with her arms raised above her head, she gleefully exclaims, "Life is good!"

Penny objects to the admission of the video, arguing (1) that her statement on the video constitutes inadmissible hearsay under Illinois Rule of Evidence 802; and (2) that Defendant Bill cannot meet the requirement of authentication of the video under Illinois Rule of Evidence 901.

Discuss whether the video should be admitted, with citations to the Illinois Rules of Evidence and/or relevant Illinois case law.
